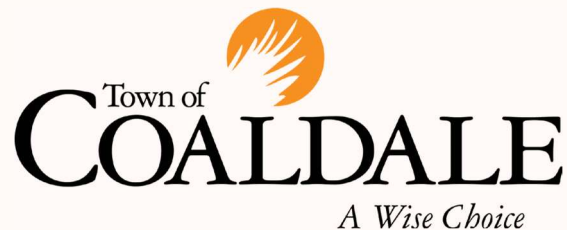

Cemetery Fees & Regulations

Selected Bylaw Regulations

Please find the following excerpts from the Town of Coaldale Cemetery Regulation Bylaw for your convenience.

- Fees must be paid in full prior to the use of any grave.
- The purchaser of any Town Cemetery lot may not transfer the said lot to any person unless all such transactions are approved in writing by the Administrative Designate.
- A certificate of purchase will be issued to each purchaser and the Administrative Designate shall collect any and all fees for the opening and closing of graves and other work as provided.
- All applications for interment must be made 48 hours prior to the time established for burial from May 1 to October 31 and 96 hours from November 1 to April 30 inclusive.
- No burial shall be permitted on a Sunday or statutory/declared holiday except on special permit in writing from the Administrative Designate.
- Opening and closing outside of regular workings hours will require an additional charge of \$350.00. Regular hours are 8 a.m. to 3:30 p.m. Monday to Friday excluding holidays.

- No person shall place artificial flowers on any lot in Sections 'A' or 'B' during the period of May 1 to October 31 inclusive; and Section 'C' and Reserve Sections 'A' at any time of the year.
- The Town shall have full authority to remove any artificial flowers during this period.
- Endowment care by the Town includes seeding of lots and grave surfaces, re-seeding, cultivation, watering and the cutting of grass and weeds as may be necessary and keeping the lots in neat condition and in good appearance.
- No trees, plants, shrubs or flowers shall be planted without obtaining special permission from the Administrative Designate.
- No interments will be permitted unless a permanent concrete vault is first placed in the grave.
- A maximum of three (3) cremains may be buried in any full sized plot unless otherwise authorized by the Administrative Designate. Any child of a deceased interred in a plot is deemed to have authority to give permission for interment in that plot.

Monument Regulations

- Vases, monuments or markers may not be attached to the cement base (ribbon strip) in the Reserve Sections.
- The Town will provide a cement base for your monument within a reasonable time after the completion of a row of graves.
- All monuments must be made of granite, limestone, marble or bronze.
- Vases will be permitted provided they are not of glass, pottery or other brittle material and they conform to the bylaw size.
- Vases must be so placed that there is a concrete or metal pad at least 5" wide between any part of the vase and the edge of the turf. The edge of the vase retaining ring should be a minimum of 2" from the edge of the turf.
- Vases must be of a permanent finish that will not wear, chip or deteriorate under normal cemetery conditions.
